Public Hearing on the District's Proposed 2019 Tax Rate

The Board first convened a public hearing to discuss the proposed tax rate for the 2019 tax year. It was noted by the Board that there were no taxpayers of the District in attendance who wished to address the Board regarding the proposed tax rate. The Board closed the public hearing on the 2019 tax rate.

Order Levying Taxes for 2019

The Board reviewed an ORDER LEVYING TAXES for the 2019 tax year as prepared by Coats Rose. After lengthy discussion, upon a motion duly made by Director Cunningham and seconded by Director Clay, the Board voted unanimously to adopt a maintenance tax rate of \$0.0875 per \$100 of assessed valuation and to adopt the Order Levying Taxes, a copy of which is attached hereto and shall be considered a part of these minutes.

Amendment to the District's Information Form

The Board then considered the Amendment to the District's Information Form (the "Amendment") that reports the District's most recent tax rate and is required to be filed with the Texas Commission on Environmental Quality and filed in the Official Real Property Records of Montgomery County, Texas. After discussion, upon a motion duly made by Director Clay and seconded by Director Ganson, the Board voted unanimously to approve the Amendment to state the \$0.0875 per \$100 of assessed valuation tax rate and to authorize the filing of same. A copy of the Amendment thus approved is attached hereto and shall be considered a part of these minutes.

There being no further business to come before the Board, upon a motion duly made by Director Ganson and seconded by Director Williams, the Board voted unanimously to adjourn.
